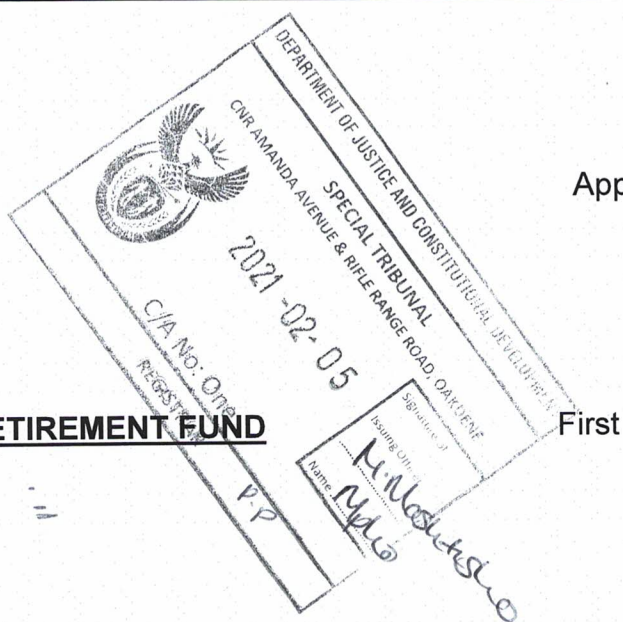

5. The costs of the revival application, and the costs reserved in the application heard on 17 December 2020, are to be costs in the cause of the action proceedings.


