The Property

GO-PRET-017

Applicant therefore seeks an order directing that the Department of Public Works, 24. Nedbank, FNB, ABSA and Standard Bank should continue to exercise control over the property pending the finalisation of the envisaged forfeiture application.

- Any person who has an interest in the property and who intends opposing the application 26. for an order forfeiting the property to the State or applying for an order excluding his or her interest from a forfeiture order in respect of the property, must enter an appearance giving notice of his or her intention in terms of section 39(3) of the POCA.
- Such notice must be delivered to the applicant: 27.



- 27.1 in the case of any person specifically identified for service in terms of this order, within 14 calendar days of service; and
- 27.1 in the case of any other person, 14 calendar days after the date when a notice of the order was published in the Government Gazette.
- 28. A notice in terms of section 39 must contain full particulars of the chosen address for the delivery of documents concerning further proceedings in this matter and must be accompanied by an affidavit setting out:
 - 28.1 the full particulars of the identity of the person giving the notice; south AFRICA
 - 28.2 the nature and extent of his or her interest in the property concerned;
 - 28.3 whether he or she intends opposing the making of the forfeiture order, or whether he or she intends applying for an order excluding his or her interest in that property from the operation of the order;
 - whether he or she admits or denies that the property concerned is an instrumentality of an offence referred to in schedule 1 of the POCA, or is the proceeds of unlawful activities and the basis for such defence;
 - 28.5 if he or she intends applying for the exclusion of his or her interests from the operation of the forfeiture order, the basis for such an application.
- 29. Any person who is affected by the order may on good cause shown, apply for reconsideration. Such application shall be made:

- 29.1 in instances where the person is able to justify the application on grounds of urgency, upon 3 days' notice (or such shorter period as the court may determine on good cause shown).
- 29.2 in other instances, upon at least 7 days' notice to the applicant and all other persons identified in this order as being persons who may have an interest in the property.
- 29. Such an application must be made not later than 8 days after the person applying for reconsideration becomes aware of the existence of the order, or within such further period as the court may consider reasonable, bearing in mind the underlying objectives of
