#### It is hereby ordered that:

#### The Property

This order relates to Erf number 3303 of the Township Jukskei View, Ext 105, Gauteng commonly known as Erf 3303, Waterfall Country Homeowners Association, Maxwell Drive Midrand, Gauteng measuring at 1105s square meters, held by certificate of registered title, T64406/2014 (the property).

## Prohibition against dealing in any manner with the property

Appointment of a Curator Bonis

The appointment of a *curator bonis* in terms of section 42 of POCA is hereby dispensed with.

The property shall remain in the care and control of the South African Police Service under the control and supervision of Lieutenant Colonel Carol Lebogang Manyaka of the Directorate for Priority Crimes and Investigations (DPCI) with a caveat on the title deed to be endorsed by the Registrar at Johannesburg Deeds Office, that the property shall not without the consent of the High Court be mortgaged, encumbered, attached and sold in execution, until the expiry of this order in terms of section 40 of POCA or until this matter is otherwise concluded.



The forfeiture proceedings shall be instituted within 90 days after publication of the notice of the making of the preservation of property order in the Government Gazette.

#### Service and publication

- The applicant must in terms of section 39 of POCA: 5
  - cause notice of this order, in the form set out in Annexure A, 5.1 together with documents supporting the application, to be served by the Sheriff on following persons:

  - 7.1 In the case of any person specifically identified for service in terms of this order, within 14 calendar days of service; and
  - 7.2 In the case of any other person, within 14 calendar days after the date when a notice of the order was published in the Government Gazette.

- 8.1 the full particulars of the identity of the person giving the notice;
- 8.2 the nature and extent of his or her interest in the property concerned:

- Any person who is affected by the order may on good cause shown, apply for reconsideration. Such application shall be made:
  - 9.1 In instances where the person is able to justify the application on grounds of urgency, upon 3 days' notice (or such shorter period as the court may determine on good cause shown).
  - 9.2 In other instances, upon at least 7 days' notice to the applicant and all other persons identified in this order as being persons who may have an interest in the property.
