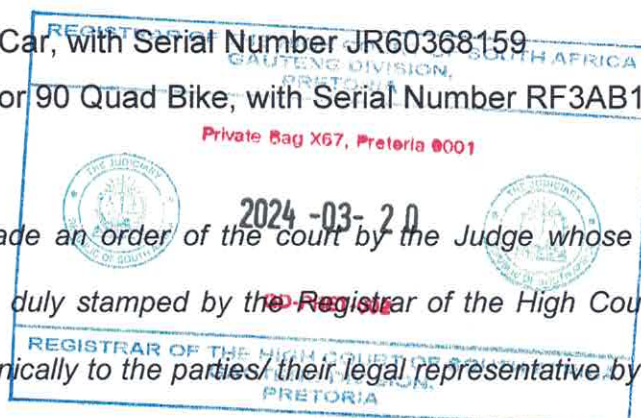

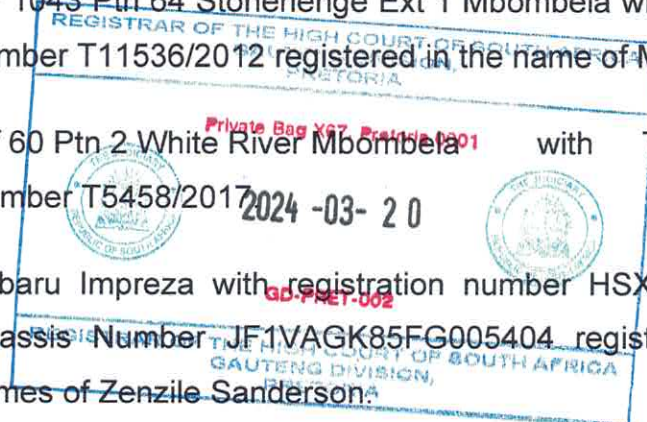

Having read the documents filed of record, having considered the matter, and having heard Adv DL Phahlane, Counsel for the Applicant,

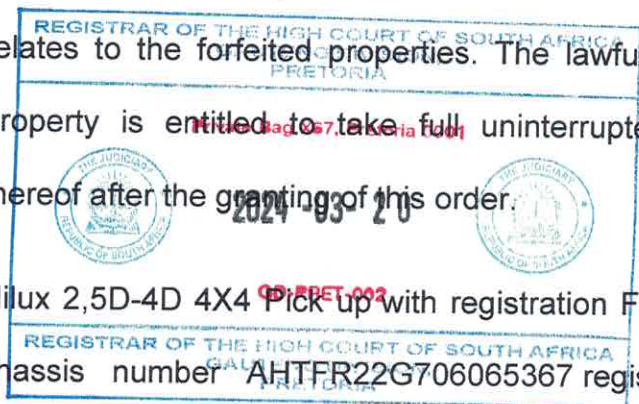
**1 It is hereby ordered that:**

- 1.1 Farm 128 Portion 75 Goede Hoop with Title Deed Number T16957/2010 in Mpumalanga Luphisi Road, Mbombela – (Casambo Lodge)
- 1.2 Farm 128 Portion 76 Goede Hoop with Title Deed number T8577/2011 in Mpumalanga
- 1.3 Erf 1043 Ptn 64 Stonehenge Ext 1 Mbombela with title deed number T11536/2012 registered in the name of M Sambo.
- 1.4 Erf 60 Ptn 2 White River Mbombela with Title Deed Number T5458/2017

- 2 Declared forfeited to the State in terms of section 53 of the Prevention of Organised Crime Act, 121 of 1998 (“the Act”);
- 3 In terms of section 56(2) of the Act, ownership of the forfeited properties shall vest in the State as from the effective date of this order, to the exclusion of the property described in paragraph 4 hereunder.
- 4 The following properties are excluded from operation of this order:

4.1 The Lotus Europa with registration number FKG630MP and Chassis Number SCCSC12107HN10872 is excluded from the application of paragraph 2 above of this order in as far as it relates to the forfeited properties. The lawful owner of the property is entitled to take full uninterrupted possession thereof after the granting of this order.



4.2 Hilux 2,5D-4D 4X4 Pick up with registration FYT001MP and chassis number AHTFR22G706065367 registered in the name of Mwakasambo. The lawful owner of the property is entitled to take full uninterrupted possession thereof after the granting of this order.

5 In terms of section 42 of the POCA, Shawn Williams of GCW Administrators (Pty) Ltd with telephone number 0827183648, is the appointed curator bonis over the property (the curator bonis). The curator bonis shall have all such powers, duties and authority as provided for in the POCA and in this order and, shall in addition, be subject to the applicable

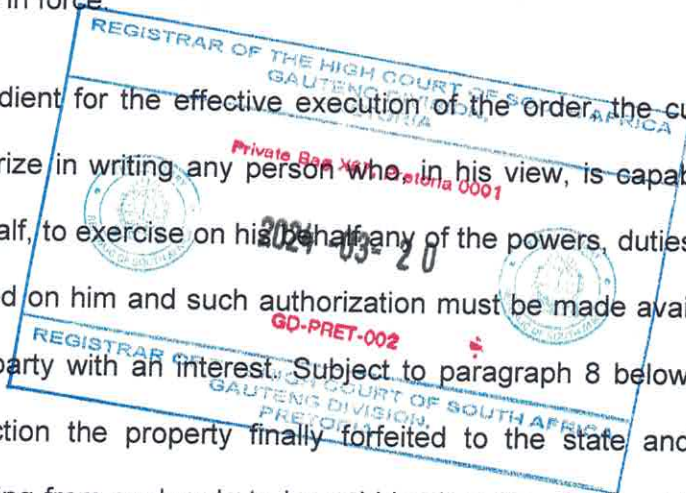
provisions of the Administration of Estates Act 66 of 1965, as well as the supervision of the Master of the High Court.

6 The curator bonis is authorised to assume control of the property and to take any movable property into his custody; take care of the property; administer the property and do anything necessary to preserve the property while the order is in force.

7 Where it is expedient for the effective execution of the order, the curator bonis may authorize in writing any person who in his view, is capable of acting on his behalf, to exercise on his behalf any of the powers, duties and authority conferred on him and such authorization must be made available on request to a party with an interest. Subject to paragraph 8 below, the curator must auction the property finally forfeited to the state and the proceeds emanating from such sale to be paid back to the victim, which is Eskom's Kusile Power Station, with Reference Number **2022-058969**.

8 Such payment to the victim shall only be made after the banking details of the victim have been provided to the Curator bonis on affidavit by an authorised manager at Kusile Power Station.

9 Any person whose interest in the funds concerned is affected by the forfeiture order may within 20 days after he or she acquired such knowledge of the order, set the matter down for variation or rescission by the Court.

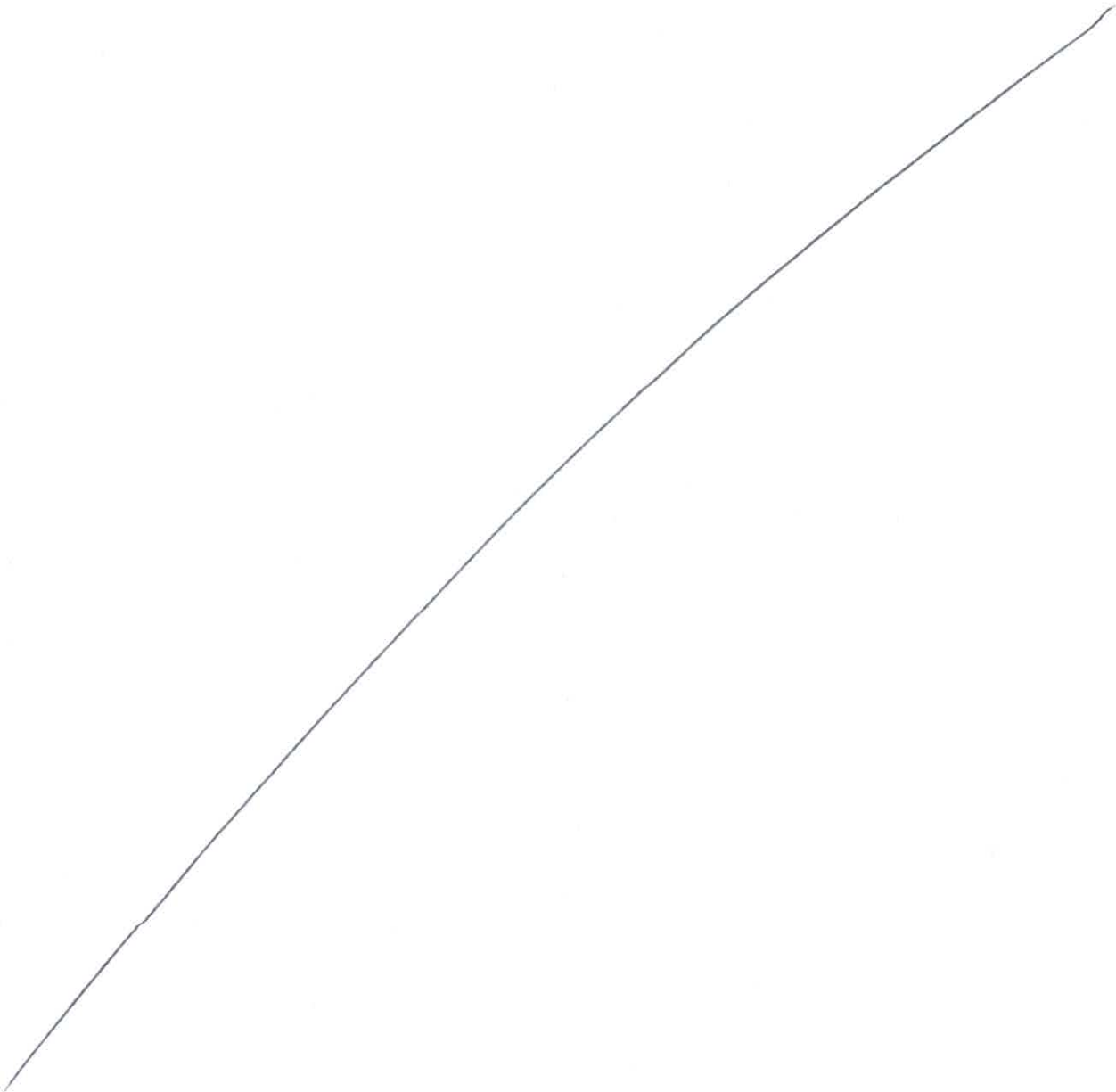
