CONSENT ORDER

It is ordered that:

1. The decision of the Department of Social Development to award the Request for Quotation described "*Request for Hygiene Equipment and Hygiene Consumables to Be Delivered for NPO's Pietermaritzburg District*" dated 19 March 2020 with order number A0749179 to the Second Respondent, is reviewed and set aside.
2. 
