It is ordered that:

1. The decision of the Department of Social Development to award the Request for Quotation described as *Supply and Delivery of Hygiene Equipment And Hygiene Consumables at Umkhanyakude District* dated 17 March 2020 with order number A0212937 to the Second Respondent, is reviewed and set aside.


