INVESTIGATION BY THE SPECIAL INVESTIGATING UNIT UNDER AUTHORITY OF PROCLAMATION NUMBER R88 OF 2022 (AS PUBLISHED IN GOVERNMENT GAZETTE NO. 46789 DATED 26 AUGUST 2022) IN RELATION TO THE NATIONAL STUDENT FINANCIAL AID SCHEME (NSFAS)

1. The SIU was established by the President of the Republic of South Africa under the provisions of section 2(1)(a) of the Special Investigating Units and Special Tribunals Act, 1996 (Act No. 74 of 1996) ("SIU Act").

- 2. On 26 August 2022, and with the publication of *Proclamation No. R88 of 2022* ("the relevant Proclamation") as published in *Government Gazette No. 46789 dated 26 August 2022*, the honourable President referred certain allegations of impropriety in connection with the affairs of the National Student Financial Aid Scheme ("the NSFAS") to the SIU for investigation. The SIU's terms of reference are apparent from the copy of the relevant Proclamation, which is attached hereto as "Annexure A".
- 3. The SIU is an independent statutory body that reports to the President on specific proclaimed matters and annually to Parliament on its general performance. In order to ensure the integrity of its investigations, the SiU's independence has been entrenched by statute. Without limiting the generality of the aforementioned, the SIU Act does not allow the SIU to report to or in any way be controlled by the State institution concerned. It is accordingly specifically recorded that the role and responsibilities of the SIU do not:
 - 3.1 include any requirement to:
 - a) report to the State institution concerned; or to
 - b) submit to any requests, measures, requirements, conditions or instructions of the State institution concerned or
 - 3.2 create a relationship of employment, service rendering, partnership, principal-and-agent or trustee-and-beneficiary between the SIU and the State institution concerned.
- 4. Under the provisions of section 5(1)(b) of the SIU Act, the SIU is obliged to charge and recover fees and expenses from the National Student Financial Aid Scheme ("NSFAS") for all work done under authority of the relevant Proclamation.
- 5. The SIU is obliged to inform the National Student Financial Aid Scheme "NSFAS" that, under the provisions of section 5(1A) of the SIU Act, if the National Student Financial Aid Scheme "NSFAS" is unable to pay the fees and expenses concerned, it is entitled to submit representations to National Treasury with a view to be exempted from such payment or any part thereof.
- 6. Monthly invoices submitted by the SIU will indicate the resources employed on the project and the actual hours billed, while supporting any expenditure invoiced.
- 7. Notwithstanding the content of paragraph 3 above, the SIU will provide progress reports which will enable the NSFAS to settle the invoices concerned.

- 8. A detailed Letter of Engagement ("LoE") will be drafted and presented to the NSFAS in due course. The LOE will include the cost estimate as well as the period envisaged for completion of the investigation. The LoE will also set out the approach to be followed and the composition of the investigation team.
