ORDER

HAVING heard Counsel for the Applicant, and having read the documents filed on record;

It is ordered that:

- 1. That pending the final determination of civil proceedings for the recovery of damages or losses suffered by the State and in accordance with the provisions of Section 4 (1) (c), Section 8 (2) of the SIU Act read with Rule 23(1) and Rule 24 of the Rules for conduct of legal proceedings in the Special Tribunal, the First to Fourth Respondents are interdicted and prohibited from selling, disposing, leasing, encumbering (including by granting rights of retention), transferring, donating or dealing in any manner whatsoever with respect to the properties listed hereunder:
 - 1.1. Erf 899, Section 6 Mont Blanc Heuwelsig EstateCeltisdal Ext 20Centurion.
 - 1.2. Section 12, Heuwelsig Office Park, Celtisdal Extension 20 Township City of Tshwane Municipal Authority Held under deed of Transfer number: ST 98112/2007
 - 1.3. A special vehicle, drill/ borer/drain or cleaner, Beifangabenchi, Powerstar series, licence number HG25SVGP Register number WXL921W chassis number LBZF56GB2FA008122A
 - The Sixth Respondent is ordered to place a caveat on the immovable properties referred above.

- The orders made in paragraphs 1 and 2 above shall operate in the interim and with immediate effect pending the finalisation of a review application ("the main application").
- That a copy of this application together with this order be served on the Respondents.
 - The Respondents may apply for a reconsideration of the order in terms of Tribunal Rule 12(9).
 - The costs of this application are reserved for determination in the review application.
