ORDER

Having read the papers filed and having heard counsel on behalf of the Applicant, it is ordered as follows:


- This application is hereby enrolled in terms of Rule 10(7) of the Rules for the conduct of proceedings in the Special Tribunal ("Tribunal Rules") and it is to be dealt with in Chambers and without prior notice to the Respondents in terms of Rule 24 (1);
- In accordance with Rule 24 of the Special Tribunal Rules, and Section 8(2) of the Special Investigating Units and Special Tribunals Act 74 of 1996, the First and Second Respondents are hereby prohibited with immediate effect from selling,

disposing, leasing, encumbering (including by granting rights of retention), transferring, donating, or dealing in any manner whatsoever in respect of the immovable property defined and fully described as ERF 6046, MIDSTREAM MEADOWS, MIDSTREAM ESTATE EXT 79, TOWNSHIP REGISTRATION DIVISION J.R, GAUTENG PROVINCE MEASURING 601 SQUARE METERS HELD UNDER TITLE NUMBER: T80642/2019 (STREET ADDRESS: 21 PEARL CRESCENT, MEADOWS ESTATE), (the property) with all the provisions thereof, other than in accordance with this Order;

- 3. The order made in paragraph 2 above shall operate with immediate effect pending the institution and final determination of the civil proceedings (including any further proceedings) to be instituted by the Applicant within 60 Court days of the date of this order, against the respondents;
- 4. Any of the Respondent(s) so desiring may apply for the reconsideration of this order or any part thereof in terms of Rule 12(9) of the Special Tribunal Rules, and that such parties shall avail themselves to attend a judicial case management meeting as arranged by the Registrar of this Tribunal and/or the Registrar/Clerk of the Presiding Member of this Tribunal, where dates for the filing of further papers and the hearing of the reconsideration application shall be determined in terms of Rule 19 of the Special Tribunal Rules;
- 5. Pending the finalization of the application and civil proceedings referred to in paragraphs 3 and 4 above, the twentieth respondent (Deeds Registries Office:

Pretoria) is directed to register a caveat against the immovable property more fully described as ERF 6046, MIDSTREAM MEADOWS, MIDSTREAM ESTATE EXT 79, TOWNSHIP REGISTRATION DIVISION J.R, GAUTENG PROVINCE MEASURING 601 SQUARE METERS HELD UNDER TITLE NUMBER: T80642/2019 (STREET ADDRESS: 21 PEARL CRESCENT, MEADOWS ESTATE), to the effect that absent a written agreement concluded between the SIU and any of the parties in this application, in respect of the sale of the said property; or an order of this Tribunal or a Court having jurisdiction, sanctioning the transfer of the property, its transfer is prohibited;
