### DRAFT COURT ORDER (AS AMENDED)

HAVING HEARD THE COUNSEL FOR THE APPLICANT, AND HAVING READ

THE PAPERS ON RECORD, the following order is made:

- That the decision of the Bid Adjudication Committee ("BAC") dated 14
   November 2017 to approve the appointment of the First Respondent in terms Tender GEP/02/06/MRK ("the Tender") is declared invalid, reviewed and set aside.
- That the Service Level Agreement ("SLA") entered between the Third Respondent Applicant and the First Respondent dated 20 December 2017, pursuant to the tender GEP02/06/MRK, is declared invalid, reviewed and set aside.
- 3. That the Tribunal, in terms of section 8(2)(b) of the Special Tribunal Units and Special Tribunals Act ("SIU Act") orders that: -
  - 3.1. The First and Second Respondents are ordered to, within 30 (thirty) days of this order, provide to the parties Applicant and the Third Respondent, the Audited Financial Statements, invoices and/or any supporting documents regarding its income and expenses for the period of the implementation of the SLA.
  - 3.2. The Third Respondent must within 60 (sixty) days of receipt of the documents referred to in 3.1 above, inform the First and Second Respondents of the amount relating to the profit that must be paid back to the Third Respondent.

- 3.3. If a dispute arises regarding the amount to be paid back by the First and Second Respondents, the matter may be re-enrolled for a determination by the Tribunal.
- 3.4. The parties may approach the Tribunal for directives on any issue regarding the orders herein.
- 4. Costs including the costs of two counsel.
