PROCLAMATION NOTICE 287 OF 2025**by the****PRESIDENT of the REPUBLIC of SOUTH AFRICA****SPECIAL INVESTIGATING UNITS AND SPECIAL TRIBUNALS ACT, 1996 (ACT NO. 74 OF 1996): AMENDMENT OF PROCLAMATION NO. 164 OF 2024**

Under section 2(4) of the Special Investigating Units and Special Tribunals Act, 1996 (Act No. 74 of 1996), I hereby amend Proclamation No. R. 164 of 2024 (hereinafter referred to as “the original Proclamation”), by—

- (a) the extension of the period referred to in the fourth paragraph of the original Proclamation to the date of publication of this Proclamation; and
- (b) the substitution for subparagraph (a) of paragraph 1 of the Schedule to the original Proclamation of the following subparagraph:
 - “(a) the “Drop the Block” Project and the implementation thereof by the Department and the implementing agents, namely, Lepelle Northern Water and Sedibeng Water, as well as suppliers or service providers appointed by the Department, Lepelle Northern Water and Sedibeng Water for the “Drop the Block” Project;”.
