#### **PROCLAMATION 303 OF 2025**



## by the PRESIDENT of the REPUBLIC of SOUTH AFRICA

# SPECIAL INVESTIGATING UNITS AND SPECIAL TRIBUNALS ACT, 1996 (ACT NO. 74 OF 1996): AMENDMENT OF PROCLAMATION NO. R.2 OF 2020

Under section 2(4) of the Special Investigating Units and Special Tribunals Act, 1996 (Act No. 74 of 1996), I hereby amend Proclamation No. R.2 of 2020, as published in *Gazette* No. 42979 dated 31 January 2020 (hereinafter referred to as "the original Proclamation")—

- (a) by the substitution for paragraph 1 of the original Proclamation of the following paragraph:
  - "WHEREAS allegations as contemplated in section 2(2) of the Special Investigating Units and Special Tribunals Act, 1996 (Act No. 74 of 1996) (hereinafter referred to as "the Act"), have been made in respect of the affairs of South African Airways SOC Limited and South African Airways Technical SOC Limited (hereinafter collectively referred to as "the Institutions");
- (b) by the substitution for the words "the SAA" wherever they appear in the original Proclamation and the Schedule to the original Proclamation, of the words "the Institution";
- (c) by the extension of the date mentioned in the fourth paragraph of the body of the original Proclamation to date of publication of this amendment Proclamation;
- (d) by the substitution for paragraph 1(b) of the Schedule to the original Proclamation of the following paragraph:
  - "(b) maintenance, repair and operations services, including the provisioning of aircraft and avionic components, spare parts, landing gear, support services, consumables, workshop instruments, oxygen generators, battery cells, modifications and inspections;";
- (e) by the deletion in paragraph 1 of the word "and" at the end of paragraph (c);
- (f) by the deletion in paragraph 1 of the comma at the end of paragraph (d) and the substitution thereof with the expression "; and";
- (g) by the insertion of the following paragraph in paragraph 1 of the Schedule to the original Proclamation after paragraph (d):
  - "(e) supply of transportation services for cabin crew members at various outstations in terms of RFQ-GSM167/2018.";
- (h) by the substitution for paragraph 3 of the Schedule to the original Proclamation of the following paragraph:
  - "3. Any undisclosed or unauthorised interests which board members, employees, officials and agents of the Institutions may have had in—
  - (a) bidders, vendors, suppliers, service providers, contractors or their agents;
  - (b) bidders, buyers, deal brokers, actual or potential investors or shareholders or their agents; or
  - (c) any other person or entity,

in relation to the allegations set out in paragraphs 1 and 2 of this Schedule, and the extent of any actual or potential benefits derived directly or indirectly by them from such undisclosed or unauthorised interests."; and

- (i) by the addition of the following paragraph in the Schedule to the Proclamation:
  - 4. Any irregular, improper or unlawful conduct by—
  - (a) board members, officials, employees or agents of the Institutions;
  - (b) bidders, vendors, suppliers, service providers, contractors or their agents;
  - (c) buyers, deal brokers, actual or potential investors or shareholders or their agents; or
  - (d) any other person or entity,

in relation to the allegations set out in paragraphs 1 to 3 of this Schedule.".
